Ragging is a crime



What constitutes Ragging ?

Ragging constitutes one or more of any of the following acts :

- any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
- indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
- asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student;
- any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher;
- Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
- any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from

actively or passively participating in the discomfiture to fresher or any other student ;

- any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.

Punitive Action against students indulging in Ragging

Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee/Proctorial Board of the College, following any one or combination of actions may be executed against the student's indulged in ragging.

1. Cancellation of admission
2. Suspension from attending classes
3. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
4. Rustication from the college for a period ranging from a week to one year or more.
5. Expulsion from the college and consequent debarring from admission to any other institution.
6. Collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggings.

According to Ordinance XV-C, ragging means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students and include individual or collective acts or practices which

- Involve physical assault or threat to use physical force.
- Violate the status, dignity and honour of women students,
- Violate the status, dignity, and honour of students belonging to the SC/ST.
- Expose students to ridicule and contempt and affect their self-esteem.

- Entail verbal abuse and aggression, indecent gestures and obscene behavior.

Students of the College are expected to behave responsibly, both inside and outside the College. Ragging in any form is a criminal offence and is strictly prohibited. Any occurrence should be immediately reported to the Anti-ragging Committee.

Anti-Ragging Committee

College, has a zero tolerance policy towards ragging. The UGC Regulations 2009 mandated committee against Ragging consists of senior teachers and ensures compliance with the provisions of the UGC regulations / guidelines as well as the provisions of any law for the time being in force concerning ragging. The committee also monitors and oversees the performance of the Anti-Ragging squads in prevention of ragging in the college campus.
